

# KIDS ADVENTURE CLUB 2024

## 1 January 2024 – 31 December 2024

### Terms & Conditions

---

The Kids Adventure Club 2024 Programme (the “Programme”) is a kids’ programme organised by The Seletar Mall Pte Ltd (the “Organiser”). By becoming a member of or participating in the Programme or being a Representative (as defined below), you agree to accept and be bound by the terms and conditions set out herein (the “T&Cs”). The T&Cs may be amended by the Organiser at any time by posting the amended terms and conditions at The Seletar Mall website at <https://www.theseletarmall.com/> without prior notice. Any continued participation by the Member (as defined below) in the Programme after the amendment of the T&Cs shall be deemed to be acceptance of the amended terms and conditions by the Member and his/her Representative. If the Member or his/her Representative does not agree to the amended terms and conditions, the Member shall have the right to terminate his/her membership in accordance with the T&Cs.

#### 1. AGREEMENT

- i. You hereby represent and warrant that you are at least 18 years old and have the necessary legal capacity, right, power and authority to agree to the T&Cs, and that you are contracting as parent or guardian of a child or ward who is less than 18 years old and who is registering for and/or participating in the Programme, and you agree as his/her parent/guardian, both in your personal capacity and on behalf of your child/ward, to be bound by the T&Cs and any other terms and conditions applicable to the Programme (including without limitation any specific terms and conditions applicable to any specific activities or missions) (collectively the Programme T&Cs”), and to be liable for your child’s or ward’s acts and omissions while registering and/or participating in the Programme, and you also agree to ensure that your child or ward observes the Programme T&Cs.

#### 2. REGISTRATION

- i. The Programme is open to children aged 4 to 12 years old at the time of registration, and represented by a parent or legal guardian (each a “Representative”). A unique membership identity number will be assigned to each registrant who successfully registers as a member of the Programme (each a “Member”).
- ii. Each Representative may represent up to five (5) children in registering for membership accounts.
- iii. At the point of registration, the Representative must provide the following:
  - a. a valid mobile number of the Representative and email address at which the Representative may be contacted; and
  - b. the Member’s information, including, full name, birth month and year, age and gender.
- iv. A Representative is required to be present at the point of registration.
- v. To register for a membership account, a minimum spend of \$70 in 3 same-day receipts is required.

- vi. All registrations must be done at the Kids Concierge located at the Information Counter at Basement 2 of The Seletar Mall.
- vii. Registration of the programme will close on 30 June 2024.
- viii. The Organiser reserves the right to reject any application for registration in its sole and absolute discretion without giving any reason and without liability to any party.

### **3. PROGRAMME**

- i. Upon successful registration, the Member will receive a mission booklet and a welcome gift. The welcome gift is limited to the first 1,000 registrants only, on a first-come-first-served basis and while stocks last.
- ii. Upon completion of all the missions, the Member will receive a completion gift. An EDM will be sent to the email address provided by the relevant Representative at the point of registration by 31 December 2024 with instructions on how to redeem the completion gift. The completion gift is limited to the first 1,000 redemptions only, on a first-come-first-served basis and while stocks last.
- iii. The Programme will run for the period from 1 January 2024 to 31 December 2024 (the "Programme Period").
- iv. All missions must be completed by 31 December 2024 to be eligible for the completion gift.
- v. The Organiser reserves the right to change the Programme Period at any time in its sole and absolute discretion without prior notice and without liability to any party.
- vi. Each membership and its corresponding privileges are non-transferable.
- vii. There is no renewal of memberships upon expiry.
- viii. A fee of \$8 will be charged for replacement of the mission booklet, payable at the Kids Concierge, located at the Information Counter at Basement 2. All stamps will be awarded based on the rewards information recorded in our system.
- ix. The Organiser has the right to issue instructions or further information in relation to the Programme (or any aspect thereof) to the Members and the Representatives from time to time which shall be binding on the Members and the Representatives.

### **4. REDEMPTIONS**

- i. Redemption of mission stamps will commence on 1 January 2024.
- ii. The participant must present his/her original receipt(s), corresponding charge slip(s), corresponding bank/debit/credit card(s) used and his/her photo ID on the same day of purchase at The Seletar Mall Information Counter, Basement 2 from 10 a.m., with the last redemption to be made at no later than 10 p.m. Receipts dated after 9.45 p.m. can be used for redemption on the next day.
- iii. We strongly encourage Members to redeem the stamps personally at the Kids Concierge, and parents/legal guardians to accompany the Members during redemption at all times.
- iv. Members are required to present their mission booklet during redemption.

## 5. CANCELLATION & TERMINATION

- i. The Member may terminate his or her membership by submitting a written notification along with the mission booklet at the Kids Concierge, located at the Information Counter at Basement 2. The membership will be terminated within seven (7) working days from the date of request. Upon termination, the Member will no longer have access to any activities and privileges under the Programme.
- ii. The Organiser, may at its sole discretion, terminate a membership at any time without prior notice and without liability to any party.

## 6. DISCLAIMERS

- i. The Organiser makes no warranty or representation of any kind, including without limitation any warranty as to the quality, merchantability or fitness for a particular purpose, in respect of any participating merchants' goods and services. Any dispute about the same must be resolved directly between the Member / Participant and the participating merchants.
- ii. The Organiser shall not be liable for any loss (including, without limitation, direct, indirect, special, incidental, consequential or punitive loss), damage, personal injury or death howsoever caused arising directly or indirectly out of or in connection with the Programme, the Programme T&Cs (or any of the matters contemplated therein), any goods and services of the participating merchants and/or any gift/prize redeemed or awarded in connection with the Programme, whether for breach of contract, tort or other cause of action, save for any liability that cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).
- iii. All gifts/prizes are subject to their respective terms of use (if any). If applicable, all warranty claims in regards to a gift/prize shall be directed to the applicable manufacturer / retailer. Except to the extent that they may not be excluded by law, no representations, warranties, terms or conditions that are not expressly stated in the T&Cs apply to the Programme or any gift/prize, and all implied warranties are excluded, including but not limited to, the implied warranties of satisfactory quality, merchantability or fitness for a particular purpose of any gift/prize.
- iv. All gifts/prizes are on a first-come-first-served basis and while stocks last.
- v. Gifts/Prizes are not transferable or exchangeable and non-cash gifts/prizes are not exchangeable for cash. Where applicable, no extension to the validity period of any gift/prize shall be allowed. Members and Representatives are solely responsible, and the Organiser accepts no responsibility, for any tax or other liability that may arise from any gift/prize.
- vi. The Organiser and the participating merchants reserve the right, at any time in their sole and absolute discretion, to substitute, withdraw, cancel, add to or alter any complimentary item or gift/prize offered without prior notice and without having to disclose any reason therefor and without any payment or compensation whatsoever.
- vii. The Organiser reserves the right to revoke any Member's entitlement to any gift/prize if the Member or his/her Representative has breached any of the Programme T&Cs.
- viii. In the event of any inconsistencies between these terms and conditions and any brochure or marketing, promotional or other materials relating to the

Programme, the Organiser's final decision on such terms and conditions shall prevail.

- ix. The Organiser reserves the right to suspend, cancel or terminate the Programme and/or remove or vary any of the privileges or entitlements under or in relation to the Programme, at any time, in its sole and absolute discretion without prior notice and without liability to any party.
- x. Additional terms and conditions may apply to certain activities or missions under the Programme.

## **7. Personal Data Protection Act (Consent Paragraph)**

- i. By becoming a member of or participating in the Programme or being a Representative, you agree and consent that:
